3. We will only collect and retain information that is necessary for the clubs to meet or fulfil their activities and functions relating to membership applications and other information collected as a result of accessing facilities and services provided by the clubs.

5. We will only use personal information in relation to Membership except where we have a duty at law to provide it for other purposes.
6. Members have the right to access their personal information. If any of that information is found to be incorrect, a member has the right to amend it.
